Electric is Furnished. Each booth will have back and side curtains. You may NOT use a sound system.

**Insurance:** Proof of the following insurance must be filed prior to setting up your display/concession.

**Bodily Injury Liability** \$100,000 per occurrence

**Property Damage Liability** \$50,000 per occurrence

**Combined Single Liability** of \$100,000 per occurrence.

Friday July 16 – Saturday July 17 & Saturday 18

8am to 3pm ONLY

**Absolutely no vehicles will be allowed under or around the entrance doors of the Grandstand beginning 2pm on days of set-up.**

**Passes & Parking:** parking is free and we will show you the area for vendor parking upon arrival. A maximum of 4 Vendor Passes per exhibit.

**Display Removal:** you may begin to remove your displays
